Official Rules

- The official sponsor and administrator of the #GiveThanks Campaign (“Contest”) is the Chautauqua Region Community Foundation (“CRCF”) located at 418 Spring St. Jamestown, NY 14701.
- Official entries will be accepted online at www.crcfonline.org starting Wednesday November 1, 2017 ending Monday November 20, 2017 at 5:00pm.
- No purchase necessary.
- One entry per person.
- Entrants must be 18 years of age or older to participate.
- Open to legal residents of the United States.
- Employees and board members of CRCF are not eligible to participate.
- Entrants cannot submit for an organization that they are a paid employee of.
- The Contest is subject to all applicable federal, state and local laws and regulations; void where prohibited by law.
- Eligible charities submitted by the entrant must have a charitable status, whether a public charity, church, school, or unit of government (for a charitable purpose) as described in Section 501 (C) (3) of the Internal Revenue Code.
- Eligible charities must be located in the Southern Chautauqua Region (or Randolph, NY).
- In the case that an entry is found to be invalid an attempt will be made to contact the entrant via the email address provided.
- CRCF shall have no liability for an entrant’s failure to receive such notices due to spam or other security settings or their provision of incorrect contact information.
- CRCF requests that all comments made as part of an entry be positive in nature, negative comments containing defamatory statements and/or profanity will result in the entry being disqualified.
- Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, logins or other methods will void that entrant’s entries and disqualify the entrant.
- CRCF reserves the right to disqualify any entrant at their sole discretion.
- Five (5) organizations will randomly be selected, from a pool of all valid entries received throughout the Contest Period, at a time and location to be determined by CRCF.
- The odds of winning the contest will be determined based on the overall number of entries.
- Winners do not need to be present for their designated charity to receive their award.
- Winners will be publicly announced on November 28, 2017 on CRCF’s website, located at www.crcfonline.org and Facebook Page www.facebook.com/crcfonline.org.
- The Contest is in no way sponsored, endorsed or administered by, or associated with Facebook.
- Selected winners (individual entrants) will receive no personal or monetary benefit as a result of the Contest, their designated charity will be the recipient of a charitable grant award.
- Each winner’s designated charity will be awarded a \$1,000 grant to be used exclusively for charitable purposes, the grant will be awarded on or before December 31, 2017.

- The grant award is nontransferable. No substitution of award or transfer/assignment of the award to others by winners or designated charities is permitted.
- The charity submitted by the winner may be required to sign and submit an affidavit of eligibility, applicable tax forms, liability releases and other relevant paperwork.
- CRCF assumes no responsibility for any technical or human errors, which may occur in the processing of submissions in the Contest. Including technical errors or delays which could affect submission, including whether such submission is ultimately received by CRCF, and may arise from, among other things, high volumes of internet traffic, failures in the nominee's internet service, unauthorized intervention by third parties, or other technological problems.
- If, for any reason, the Contest is not capable of running as planned, including infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of CRCF which corrupt or affect the administration to conduct the Contest, then CRCF reserves the right in its sole discretion to cancel, terminate, modify or suspend the Contest.
- By submitting an entry, you understand that CRCF, anyone acting on behalf of CRCF, will have the right, where permitted by law, without any further notice, review or consent to use the winner's name, likeness, and entry for purposes of advertising.
